## **Our People**

- SMHG hosted over 160 guests at the popular Volunteer Appreciation dinner. This past year 260 volunteers donated over 16,254 total hours.
- 36 employees were recognized at the annual Long-Service Awards, their commitment equaling 370 years. One at 30 years; four at 20 years; five at 15 years; eleven at 10 years; and fifteen at 5 years. A total of 370 years of service.

## **Our Work**



SMHG is proud to be awarded 'Accreditation with Commendation' from Accreditation Canada.



This past year we partnered with the University of Alberta on a number of special projects including the workplace resilience video and dentistry study. The video project was conducted through the University of Alberta's Translating Research in Elder Care (TREC) program.



Other projects we partnered with TREC include: The Wave 7 TREC study, Breathing study and the Pet Therapy study. The Wave study was conducted from September 2023 - May 2024 where TREC collected nearly 3500 surveys as part of the latest Wave of data collection for the TREC Measurement System (TMS) survey in Alberta. The results of the surveys contribute to policy recommendations to the government, support positive change through evidence-based intervention projects and facilitate data-driven decision making.





# Financial Summary Revenue April 1, 2023 - March 31, 2024



Alberta Health Services Long-Term Care and home care funding accounts for 55% of total revenue which is applied to direct resident care, therapeutics, recreation, pastoral care, and specialized services.


Accommodation fees account for 30% of revenue and is applied towards food/meals, building maintenance and housekeeping services.

COVID funding accounts for 2% of revenue and is applied to additional care & recreation staffing.

Grants and donations help cover 4% of revenue and is for capital resident care equipment such as beds, lifts, building improvement expenses, Cultural Day's event and summer student grants.

The remaining 10% of revenue is derived from our business ventures, client and program fees, and investment income. Part of this revenue is used for staff learning & development.
